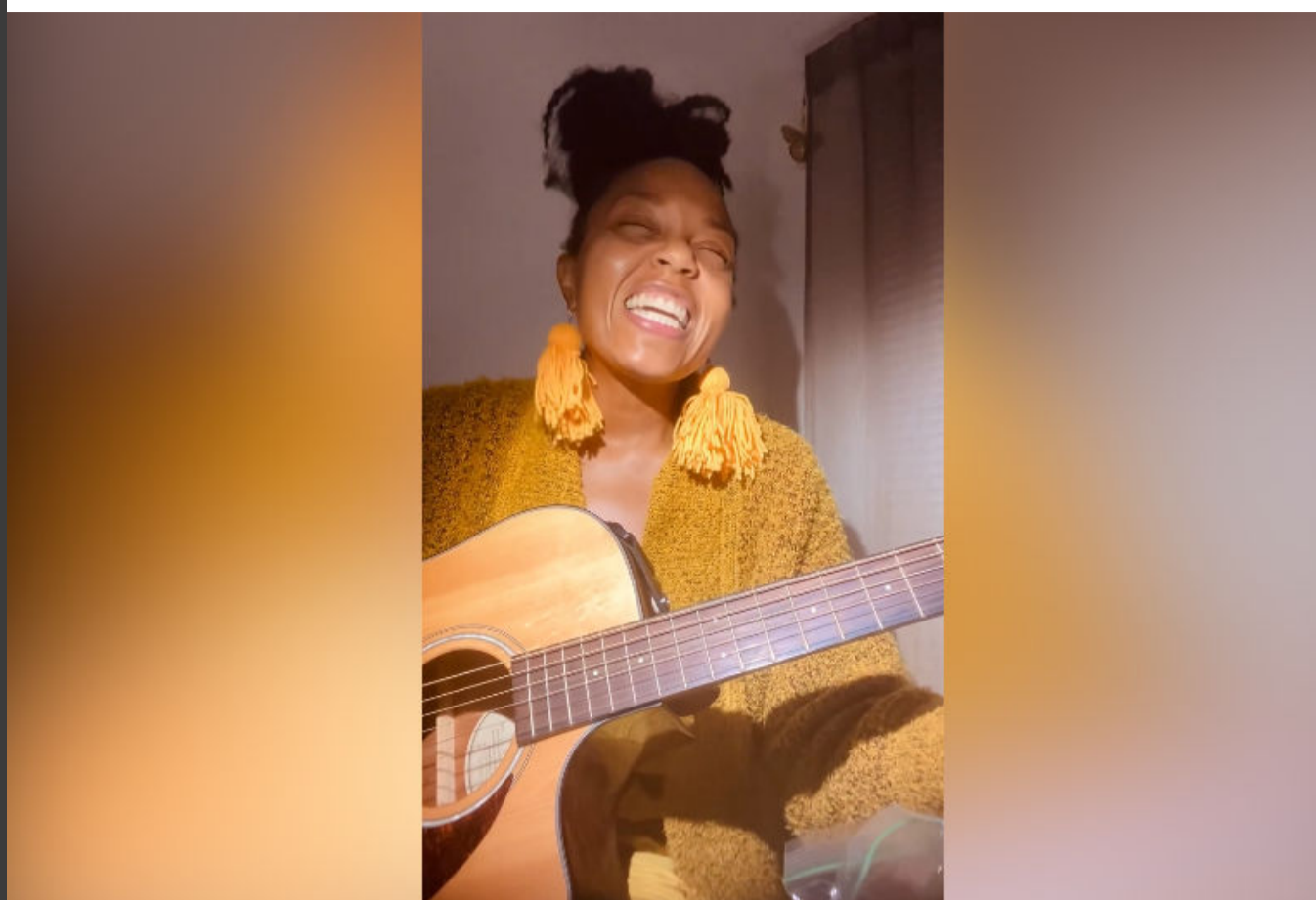

Over \$10,000 in Grocery Gift Cards Distributed at Berkley Grocery Giveaway

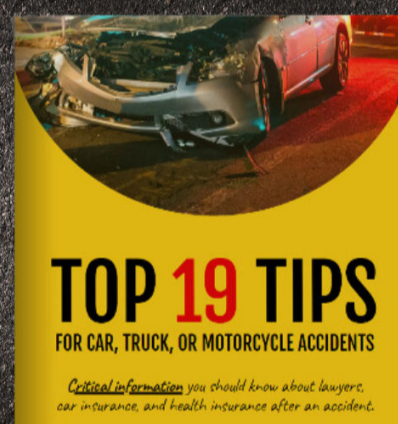
