Cooper Hurley Supports Blankets for the Homeless in Facebook Likes Campaign

Mariah Smith has a poignant reason to care about Hampton Roads' homeless people over the holidays. She was abandoned on Christmas Eve as a newborn.

Mariah was adopted and brought up in a loving household but she later returned to the streets to help the homeless. Now, 22, Mariah is the founder of Blankets for the Homeless, a Virginia Beach-based nonprofit.

When she was 17, Mariah was eating at a Sonic restaurant when she saw a homeless man nearby who was shivering. Mariah pulled a blanket out of her car, collected the food she'd just ordered and gave it to the man.

He wrapped the blanket around him and he started eating. The idea for a nonprofit was born. Mariah went home and made a flier with her phone number asking for donations of used blankets. Within a week, she had distributed more than 300 fliers at oceanfront hotels, local businesses, schools and churches. She received 50 blankets in two days.

“Since then it has grown into so much more than blankets. It’s hats, gloves, hoodies, jeans, walking shoes, tents, toiletries, basically anything that the homeless community needs,” she said.

“The need is always there and it’s always great. It just changes as the weather does,” she said.

As well as homeless people on the streets, Blankets for the Homeless helps families who are living in hotels and in their cars.

“A lot of time they are working and simply not making enough to put down a security deposit and get into an apartment,” Mariah said.

Over the holidays, Blankets for the Homeless runs a stocking and toy event. People in the community make stockings and fill them with toys. Blankets for the Homeless gives the stockings to people living on the streets and in hotels.

“It gives them a special Christmas that they would not have otherwise,” Mariah said.

Dangerous Drug Xarelto May Cause Uncontrolled Bleeding

You may have seen the high profile TV ads for the blood-thinning drug Xarelto. If you or a loved one took Xarelto and had to be hospitalized for bleeding, you should call our firm to talk about a potential claim.

Xarelto (rivaroxaban) is touted as a modern miracle drug that can significantly lower the risk of having a stroke. It can treat and help prevent deep vein thrombosis and pulmonary embolism and reduce the risk of blood clots after a hip or a knee replacement.

Thousands of older people in Virginia and North Carolina are taking this drug.

Despite the ads that feature older athletes and sports players, there is a frightening downside to this blood thinner. Xarelto is the subject of more than 10,700 federal and state lawsuits that link the drug to internal bleeding, gastrointestinal problems, brain hemorrhage and death.

These lawsuits have not stopped makers Bayer and Janssen Pharmaceuticals from broadcasting their TV commercials for the drug for the last few years

Arnold Palmer, the legendary golfer, was featured in ads for the anticoagulant drug. In a recent blog on our website we wrote about speculation that Xarelto may have been a factor in his death.

Although the big drug companies tout Xarelto as a replacement for warfarin which has downsides such as adverse food and drug interactions, a 2011 study in the New England Journal of Medicine found no evidence that Xarelto is more effective than warfarin.

Unlike warfarin, which has been used since the 1950s, there is no known antidote to stop uncontrollable bleeding with Xarelto.

McDonalds Holiday Lights on the Beach

Where: Southern boardwalk, Virginia Beach

When: Nov 18, 2016 to Jan 1, 2017 – 5:30 p.m. to 10 p.m. Sunday through Thursday and 5:30 p.m. to 11 p.m. Fridays and Saturdays.

Admission - \$15 per car, \$20 for a combo ticket including Santa's Seaside Village.

Drive through 30 blocks with displays of lights in a nautical theme. The lights are changed up each year and the south section of the boardwalk is closed off from walkers.

Newport News Celebration In Lights

Where: Newport News Park, Newport News

When: Nov. 24, 2016 - January 1, 2017. 5:30 to 10:00 p.m. every night.

Admission: \$12 per car.

Drivers pass through two miles of holiday light displays with more than 800,000 individual lights in a more rural setting in northern Newport News.

Dominion Garden of Lights at Norfolk Botanical Garden

Where: Norfolk Botanical Garden, 6700 Azalea Garden Rd., Norfolk,

When: Nov. 24 – Dec, 31, 2016 from 5:30-10 p.m.

Admission: \$20 per car, \$25 per car on Fridays, Saturday and Sundays

The botanical garden is transformed into a winter wonderland where you can enjoy a 2-mile drive through thousands of lights themed as the four seasons.

Annual Pagoda and Garden Lightfest

Where : TowneBank Fountain Park at Town Point Park, downtown Norfolk

When : Nov. 19 to Dec. 31 at Town Point Park

Admission : free

Walk through the beautiful display of lights featuring more than 40,000 sparkles of friendship in the Pagoda and the garden.

Peninsula Woman Hired Cooper Hurley After She was Hurt in I-64 Truck Wreck

Aubrey Turner from York County hired Cooper Hurley Injury Lawyers after she was badly injured in a wreck involving a tractor-trailer on Interstate-64 in Hampton.

She describes her terrifying accident in this video. She was the passenger in a car that was hit from behind by an 18-wheeler. “I had disk issues in my back. I had hip problems and chronic whiplash,” she said. She also suffered ongoing problems with chronic headaches and post-traumatic stress disorder (PTSD).

She worked with kids with autism at the time of the wreck and one of her clients recommended she talk to John Cooper of Cooper Hurley Injury Lawyers.

Aubrey said the firm made everything simple and removed the burden of dealing directly with an insurance company.

“It was just a single phone call. Everything was taken care of. It was nice. They organized it exactly how it needed to be organized,” she said.

Aubrey lost her job and her health insurance shortly before her accident. She said Cooper Hurley was able to find doctors who treated her ongoing problems.

“John just wrote a letter that said ‘I have her under my wing and I’m going to be taking care of her, so if you have anything you need to say to her, you have to say it to me now’,” she said.

“I like that John Cooper made us feel comfortable from the very first meeting to the time we got our settlement check. It was wonderful ...every question we had was answered completely. There were no guessing games with him.”
