Three cases were reported in *Virginia Lawyers Weekly*.

#### \$895,000 Settlement for a Tow Truck Driver Hurt by a Drunk Driver

Our client, a young man from Portsmouth was seriously injured by a drunk driver when he was working as a tow truck driver on the I-664 Monitor Merrimac Memorial Bridge-Tunnel (MMMBT) in Newport News.

As he tried to secure a tow for a driver who had broken down on the bridge, his truck was hit by a car. The driver was tested by the hospital and found to be driving under the influence of alcohol.

The tow truck driver suffered serious injuries including a concussion, a fracture of the clavicle, a broken ankle bone and injuries to his knee.

He was wheelchair-bound for months and was unable to do his job and play with his kids. He has struggled to come to terms with the traumatic brain injury he suffered.

Attorneys John Cooper and Jim Hurley filed a lawsuit against the drunk driver and responsible insurance companies in Newport News Circuit Court. A settlement of \$895,000 was achieved at mediation.

This case again highlights how drunk driving destroys lives. If you see a tow truck by the side of the road, you should know its driver is protected under Virginia's "Move over Law." Move over a lane or slow down. You can be fined for violating this law.

#### \$425,000 for a Driver Who Injured his Shoulder in a Chesapeake Crash

A rotator cuff injury can derail your life. That's what happened to a Cooper Hurley client who suffered a serious shoulder injury in a wreck in Chesapeake.

Our client collided with another car. Police reports found a 19-year-old driver caused the collision by making a left turn on a solid green light in front of our client. The young man failed to yield.

The injured person was driving his employer's pick-up truck. He suffered multiple tears in his shoulder. His painful injuries required two surgeries and an extensive course of physical therapy. Even after successful surgery, an arm may never have the strength or the range of motion as before the injury.

Cooper Hurley attorneys John Cooper and Griff O'Hanlon filed a lawsuit in Chesapeake Circuit Court. An extensive claim for future medical expenses was made, which was disputed by the attorneys for the at-fault driver's insurance company. Our client was awarded a settlement of \$425,000.

### **\$350,000 Settlement for a Man Who was Rear-Ended by a Dump Truck**

Commercial trucks cause some of the most serious wrecks we see on the roads. Our client was hit from behind by a dump truck when he was driving in Virginia Beach.

He complained of head and neck pain immediately after the accident. A mild traumatic brain injury he received in the wreck caused him ongoing headaches. He also had problems focusing and photosensitivity. He was able to return to his job, but the injured neck bothered him on a chronic basis.

Attorneys John Cooper and Jim Hurley filed a lawsuit in Norfolk Circuit Court. The case was against the trucker and his company. A settlement of \$350,000 was reached with the insurance company for the dump truck driver on the brink of trial.

The office was custom designed specifically for our law firm three years ago. It contains a large conference room, seven offices, a kitchen, two bathrooms and a spacious reception area.


