# Norfolk's Academy of Music Pulls the Strings in Helping the Disadvantaged

John Dixon's first love was for music. He started playing the piano when he was six-years-old and learned to play the pipe organ when he was a student at Southend-on-Sea in England.

But rather than studying music he went into business. He stud-


ied at Harvard Business School, married an American and went into the gaming and later the peanut distribution business.

He never lost his love of music and started playing the organ at Providence Presbyterian Church in Kempsville, Virginia Beach in 1998. In 2003, he became the Executive Director of The Academy of Music, a non-profit located in Ghent in Norfolk, that gives music tuition to kids, targeting those from low income families.

"Since our founding in 1991, we have given in excess of 100,000 hours of one-on-one music instruction. That to me is a very powerful number," said Dixon. "That is really something for a small organization."

About one in three students at the academy receive scholarship help. Dixon said some of the best local musicians teach at the academy.

Dixon said the academy faced a debt problem when he took over. He was able to return it to financial stability. In 2010, it received a Batten Challenge Grant which has allowed it to build an endowment. Dixon says the academy reaches about 1,000 students and year. Nearly 400 students receive violin lessons at Parkview Elementary School in Portsmouth and more than 200 students receive one-on-one lessons every year. The academy also holds summer camps. ....continued on page 2

The academy uses the Suzuki method of instruction in violin, viola and the cello, for students aged four and up. It held a graduation recital on Jan. 15 at Ghent United Methodist Church.

Dixon says running a small non-profit is more rewarding than working for a major international organization. "I'm so happy with this crazy composite life because I feel I am making a difference," he said.

- 4 Failure of a business to clear snow and ice after a storm and;
- 5 Trip and falls on sidewalks or in parking lots caused by unsafe walking areas with tripping hazards.

Premises liability cases are less likely to settle just by making an insurance claim than an auto accident case and often require filing suit and litigation. Although all cases are different and unique and we cannot guarantee the same result in your case, we have achieved a number of significant results for clients in recent years including a \$400,000 settlement for a woman who was injured by a falling window treatment at a hotel in Virginia Beach.
