




Cooper Hurley Injury Lawyers Welcomes New Attorney

Women who claim baby powder use caused ovarian cancer have filed thousands of lawsuits against the pharmaceutical company Johnson & Johnson. Talc is also linked to mesothelioma, an asbestos-linked cancer. In 2018, a jury awarded 22 women who claimed talc caused ovarian cancer \$4.69 billion. A \$117 million verdict was reached in New Jersey over the alleged link between talc and mesothelioma.
